Theme Week "The (De)tabooing of Science and Research"

Profile Area: Exploration

Deadline: February 11, 2025 (2 pm CET)

In its "Theme Weeks", the Volkswagen Foundation supports scientific symposia on various predetermined topics. The symposia are carried out in the same week at the Xplanatorium Schloss Herrenhausen conference center in Hanover and accompanied by a supporting program organized by the Foundation.



Research Area: Humanities, Cultural and Social Sciences, Life, Health and Technical Sciences

1 Objectives

Taboos shape the way we live together in many ways – in society, academia, culture and every-day life. They fulfil various functions: Taboos can be an expression of cultural values or a means of social control. The Duden dictionary distinguishes between the original concept of taboo in ethnology and religious studies and a meaning that refers to unspoken social rules. In the current political and media debate, "taboo" is increasingly used negatively in the sense of "out-dated", while terms such as "taboo-free" have positive connotations. As society, its norms and practices change over time, so do taboos.

As part of the theme week "(De)tabooing of Science and Research" (September 17-19, 2025), the Volkswagen Foundation would like to support events that deal with the emergence of new taboos, their consolidation mechanisms and the dissolution of old taboo topics. A particular focus will be on the taboos in academic inquiry that exist despite the fundamental academic freedom.

The symposia can focus on the following topics, for example:

- Construction of taboos in academia: How and why do taboos arise in different scientific disciplines? What role do social, cultural and historical factors play in the establishment of scientific taboos? What are the latest taboos in academia and are there signs of emerging future taboo topics?
- Consolidation and dissolution of taboos: What mechanisms contribute to the entrenchment and persistence of taboos in research over long periods? What strategies and approaches can be developed to question, dismantle, or reevaluate these taboos?
- Intercultural differences: How do taboos differ in different cultures and scientific traditions? What role do taboos play in international scientific cooperation and how can these differences be used productively?
- Effects of taboos in academia: What effects do taboos have on scientific innovation, publications and discourse? To what extent do they influence the career paths of researchers?
- The funded symposia will be accompanied by a joint program that offers time for exchange among the participants of all symposia and fosters networking.

2 Scope of Funding

Symposia funded by the Foundation take place at the Xplanatorium Herrenhausen Palace, Hanover, Germany, within the framework of the Volkswagen Foundation's funding program "Theme Weeks". The venue offers meeting and conference rooms of different size as well as a professional organizational and technical infrastructure. In addition to the provision of this infrastructure and handling of organizational tasks, symposia are supported with funds covering personnel, non-personnel, and publication costs. The foundation funds symposia with up to 50 participants.

Funds may be requested to cover the following costs:

Personnel costs

 Funds for student assistants during preparation, running and follow-up of the event in an amount not exceeding 7,000 EUR.

Travel costs

- <u>Expenses for accommodation</u> for all participants (please estimate 140 EUR per night/person)
- Travel expenses for all participants. Please also refer to the Volkswagen Foundation's Recommendations for sustainable traveling (see section 6). Please estimate the following sums per participant in the cost plan for travel to and from the event in total (please note that only costs actually incurred can be settled with the Foundation after the event):

Participants from Germany: 250 EUR
Participants from the rest of Europe: 500 EUR
Participants form the east coast of the USA: 1,000 EUR
Participants from the rest of the world: 1,500 EUR

Non-personnel costs, e.g.

- <u>Expense allowances</u> for freelancers (e.g. journalists or moderators), who are actively involved in the symposium.
- Consumables in an amount not exceeding 500 EUR.
- <u>Funds for childcare</u> costs, e.g. travel expenses, accommodation costs or allowances for caregivers. If you apply for funds for childcare, please briefly explain how it is planned and how the costs are composed.
- <u>Publication expenses:</u> The Foundation expects that the results of the symposia will be published online and open access. Typical conference proceedings and pure print publications will not be funded.

As part of the grant, the following services are provided by the Volkswagen Foundation:

- hotel reservations (please do not make any bookings yourself),
- provision of conference equipment at the Xplanatorium Herrenhausen Palace, Hanover/Germany,
- catering at the Xplanatorium Herrenhausen Palace, Hanover/Germany.

Joint Program

Applicants are requested to include the following slots into their program in order to foster exchange and networking of the participants of all symposia among each other and with representatives of the Foundation:

- Wednesday, September 17th: 9:30 am 1 pm (welcome, get-together, introduction to and overview of the symposia, lunch),
- Thursday, September 18th: after 4:00 pm (joint activity and dinner),
- Friday, September 19th: 12:00 pm 1:00 pm (joint closing, lunch).

Please note that the joint program will be in English if the working language of at least one of the funded symposia is English.

3 Application and Selection Procedure

Eligible to apply are researchers from all fields and at all career levels after the PhD, who are employed at a scientific institution in Germany. Researchers from foreign institutions can be involved as co-applicants. Applications can be submitted in German or English.

3.1 Procedure

A decision is usually made within two months of the deadline. In addition to the objectives of the respective theme week described in section 1, the scientific quality of the event, the use of innovative and interactive event formats, and the conclusiveness of the overall concept are decisive factors in the review process. The Foundation also expects active participation of PhD students and postdocs as well as a significant inclusion of female scientists among both the speakers and the participants.

4.1 Our Funding Platform

Applications and short proposals have to be submitted via the Volkswagen Foundation's <u>funding platform</u>. All templates (template, CV) are available for download on the funding platform and on the website for the respective programme announcement. Please only use the templates available for download there when submitting your application.

It is important that all applicants (PI, co-PIs, etc.) register early on in the process. Co-applicant(s) can only be invited to work on an application if they have registered. Please note that there is a maximum of four co-applicants per application.

Please submit the curricula vitae of all applicants in tabular, narrative form, using the template available for download at the funding platform or on the website for the respective program announcement. Please upload CVs of all applicants as one pdf-file.

Applications that do not meet the formal requirements will not be considered for review. The foundation can only award funds to scientific institutions.
